

Smoke Detectors

- -Test your smoke detectors monthly
- -Optimal locations, high on the wall in every room & garages
- -96 % of homes only have one smoke detector and 25% of them don't work
- -Replace batteries in all smoke detectors twice a year; Spring and Fall
- -Replace all smoke detectors that are 10 years or older



It has been brought to my attention that the only way to cut the flow of water to your Villas is at the water meter located close to your villa in the grassy area between the sidewalk and curb. You may want to consider purchasing a turnoff wrench from Lowes or Home Depot to facilitate this process. Remember, being prepared is half the battle.

<u>Mulch Problem</u>--our new mulch installation brings out the problem of clogged underground rain spout pipes. The rain spout pipes are overflowing at the outlet connection into the flower bed, thus the mess on the driveways and sidewalks. This problems can be solved by utilizing an above ground rain spout system as shown in the picture. However, the cost of this fix must be borne by



the homeowner.
